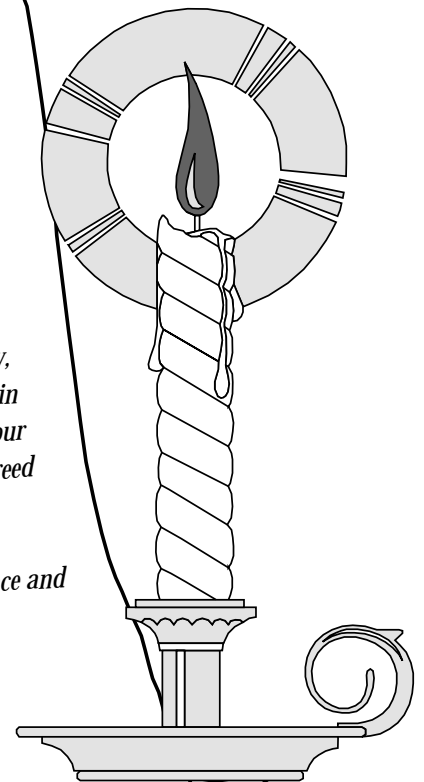
We are pleased to be able to continue our major donations to the five charitable recipients below who do their good works in our major trading areas:

- * Hydrojet Sediment Reduction System® - the patented self-cleaning system creates a turbulent action inside of the tank to remove any accumulated sediment. The Hydrojet Sediment Reduction System provides an effective way to remove sediment from the tank, which will increase the efficiency and life of the water heater.
- * 80% Thermal Efficiency
